### Low-volatility fixed income hybrid strategy

Embodies Albany's philosophy, themes, and integrated investment process without the constraints of a benchmark or significant rating, sector/instrument limitation. The strategy is designed to offer the traditional benefits of a core bond approach – capital preservation and diversification – but with higher alpha potential and the opportunity to mitigate downside risk.

### Cyclical Asset Allocation process (CAAP)

To tactical asset allocation involves monitoring the economic environment for patterns that have historically led to trends in stock market movements.

### Barbell Approach

Is formed when a Trader invests in Long and Short duration bonds, as the short term maturities are rolled over they receive a higher interest rate, raising the value.

### Risk Mitigation

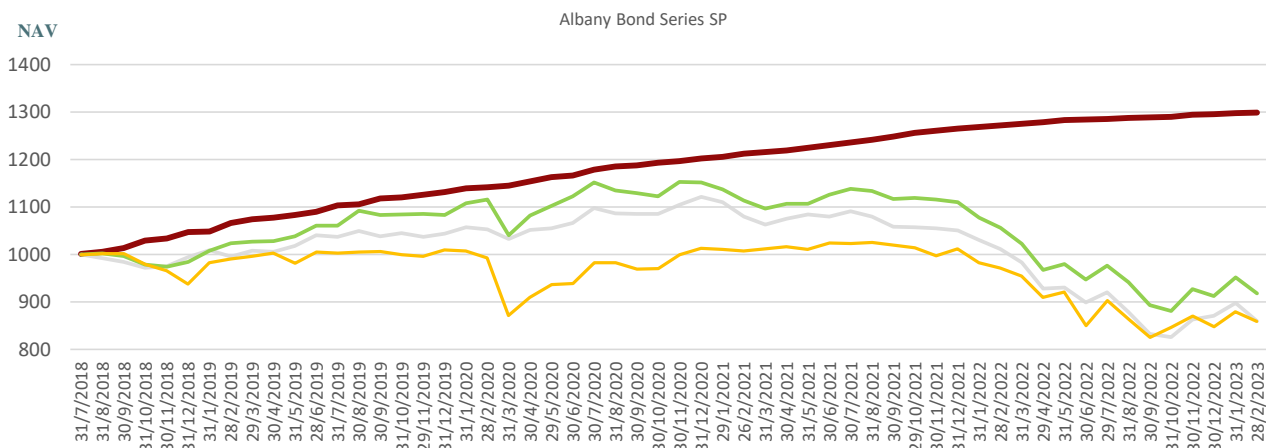
This less restrictive approach allows additional flexibility to help minimize the potential for negative returns over periods of reasonable length by defensively positioning the portfolio.
